COVID-19 SAFETY CHECKLIST - ANSWER KEY

HAND WASHING

QUESTION 1: When would you use soap and water to wash your hands?

ANSWER: As often as possible!!

This could include:

- After coughing, sneezing or blowing your nose
- After using the washroom
- Before putting on your mask
- After removing your mask
- After cleaning and disinfecting the location
- After assisting with personal care, hygiene and toileting
- Before and after mealsWhen touching "high touch"
- and all common surfaces
- The list goes on....

QUESTION 2: In what situations would you use hand sanitizer?

ANSWER:

- According to Public Health Agency of Canada, you can use an alcohol-based hand sanitizer when soap and water is not readily available (carry a mini- hand sanitizer with you)
- Can be used if your hands are not visibly dirty
- Can be used in between hand washing with soap and water

PPE - QUESTION 1: Can you clean

- If you accidently touch your face or mask
- After removing gloves (as part of PPE donning and doffing sequence)
- After removing gown (as part of PPE donning and doffing sequence)

MASKS AND PPE

SURGICAL MASKS - QUESTION 1: When is it acceptable to take off your mask?

Answer:

- At breaks and at mealtimes- as long as you maintain safe distance from others
- At the end of your shift- discard used mask in the Red Bio-Hazard bag for dirty masks only located at the "dirty PPE" area (and put on a CLEAN mask before leaving the location)

SURGICAL MASKS - QUESTION 2: When would you change your mask?

Answer:

- You would change your mask every 4
 hours during your shift
- You would change or mask at any time it gets wet, soiled or contaminated

SURGICAL MASKS - QUESTION 3: Can you ever pull down your mask around your chin?

Answer: NO!!

- Touching your mask in any way or pulling it down around your chin could cause cross-contamination and it is not safe to do so
- Leave your mask on and only remove by the loops at mealtime or breaks (ensure it is placed on a paper towel on a clean surface as per the PPE Protocol)
- Remove only when you need to change it

your gloves with hand sanitizer?

Answer: NO!!

• Gloves should be immediately be discarded once a task is completed. Then wash hands with soap and water.

only located at the "dirty PPE" area (and put**PPE - QUESTION 2:**on a CLEAN mask before leaving the location)**When is it appropriate to wear gloves?**

Answer:

- When providing direct care to an individual personal care, hygiene, toileting
- When cleaning and disinfecting using chemicals or other irritants
- When cleaning and disinfecting goggles
- When doing laundry in outbreak locations
- When administering topical medication to an individual or applying a transdermal patch

PPE - QUESTION 3: When is it NOT appropriate to wear gloves?

Answer:

- When supporting 2 different people
- When working in the kitchen preparing meals, washing and drying dishes etc
- When doing paperwork (maintain physical distance from others)
- When giving medication to individuals (mask must be worn at all times)
- At breaks and mealtimes
- When using the washroom (wash your hands with soap and water)

MASKS AND PPE

PPE - QUESTION 4:

What is the procedure for cleaning and sanitizing your googles and face shield?

Answer:

- For Goggles- Refer to the "Goggles Cleaning and Disinfection- Quick Sheet" on ShareVision
- For Face Shields: Refer to the "Face Shields- Protocol for Usage, Cleaning and Disinfecting on ShareVision

PHYSICAL DISTANCING

PHYSICAL DISTANCE - QUESTION 1: How would you use physical distancing? for the individuals you support- how would you do this throughout the day?

Answer:

- Have individuals separate when having meals
- Have individuals separated when watching tv
- If it is a larger home, utilize different floors of the location to spread out
- Use chairs from other areas of the home and place them apart to create better seating arrangements
- Ensure medication is spread out in a way that allows one individual at a time to get their meds (if not brought to them)
- Encourage individuals to do activities in their bedrooms or in quiet spaces in the location
- Constant monitoring throughout the day to ensure continuous physical distancing among individuals
- BE CREATIVE

PHYSICAL DISTANCE - QUESTION 2: How would you use physical distancing among support staff- how you would do this throughout your shift?

Answer:

This could include:

- Staff take breaks and meals at different times
- Only one person in the kitchen at one time
 If staff are supporting different individuals, ensure there is at least 6 feet between one staff and supported individual and another staff
- and supported individual
 Take turns at the computer (do not congregate around the computer) ensure computer/screen is cleaned and disinfected as per IT directives
- Only one staff at a time in the staff office
- Do not congregate near the front door at the beginning of the shift or at the end of the shift
- Allow one person at the PPE stations at one time
- Leave location at the end of the shift no
- talking in the driveway with each other BE AWARE OF YOUR PHYSICAL DISTANCE TO FACH OTHER AT ALL
- DISTANCE TO EACH OTHER AT ALL TIMES • REMEMBER WHAT 2 METERS OR 6
- REMEMBER WHAT 2 METERS OR 6 FEET LOOKS LIKE
 - THE LENGTH OF A 3-SEATER SOFA
 - THE LENGTH OF A HOCKEY STICK
 - THE LENGTH OF A TWIN MATTRESS
