- Bryan has drafted potential titles and sent forward. Reena have begun to populate responses for cascading issues. He is happy to share. They are now starting to talk about complex planning.
- Look at the scenario- between tested and waiting for diagnosis
- Some have reported that they have been instructed that if there is a positive test, the Ed would get a call and the health department would contact people connected to person
- Issue's around confidentially and privacy arising

• Issue around people with significant supports – dual diagnosis. Including: ability to administer medications PRN. Brad – they have a group looking at that

Action – Dean will reach out to the Complex Care leads to work on this and report back

MYRP:

This involves different scenarios that need to be defined: Action- Brad will sharpen up categories for MYRP and circulate to the group

Host Families:

Need to remember host family providers. Now they don't have any respite or day supports. MCCSS recognises these situations and has been having conversations.

Refusal to Work:

• Thoughts are that we need to be considered deemed essential to work.

MCCSS – this is an area where it would be beneficial to compile a sharpened assessment of the ask and who should be named essential?

Action- Dave F. and Oasis Labour Relations group will look at this
